TO BE HELD TUESDAY, AUGUST 4, 2026 IN THE COUNTY OF MUSKEGON, STATE OF MICHIGAN**

NOTICE is hereby given that any qualified elector of the County of Muskegon who is not already registered, may register to vote in the **MICHIGAN PRIMARY ELECTION TO BE HELD TUESDAY, AUGUST 4, 2026** at the office of the City or Township Clerk; the office of the County Clerk; office of the Secretary of State or at the office of a designated State Agency during their regular business hours. Registration forms can be obtained at michigan.gov/vote and mailed to the Township or City Clerk. Voters who are already registered may update their registration at www.expressSOS.com.

The last day to register in any manner other than in-person with the local clerk is **Monday, July 20, 2026**.

After this date, anyone who qualifies as an elector may register to vote in person with proof of residency (MCL 168.492) at the following:

**MUSKEGON COMMUNITY COLLEGE
Operating Millage Restoration**

This ballot proposal authorizes a new additional millage of 0.2980 mills for Muskegon Community College to restore the total amount of mills that Muskegon Community College receives for its operating millage to the original 2.4 mills approved by voters under the applicable law in May of 1993. The Headlee Amendment has reduced this operating millage to the current 2.1020 mills

Shall the limitation upon the total amount of taxes that may be levied against all taxable property within Muskegon County be increased by 0.2980 mills (\$0.2980 per \$1,000 of taxable value) for 30 years, beginning in 2026 and continuing through 2055 inclusive, to support learning environments, safety improvements, infrastructure upgrades, and long-term academic support for Muskegon Community College and other purposes authorized by law? Revenue from the proposal will be disbursed to the Muskegon Community College District and, to the extent required by law, a portion of the revenues will be captured by or disbursed to the brownfield redevelopment authorities of the City of Montague, City of Muskegon, City of Muskegon Heights, City of Norton Shores, City of Roosevelt Park, City of Whitehall, Fruitport Charter Township, and Whitehall Township. It is estimated that 2,100,000.00 will be collected in the first year that the new additional millage is authorized and levied.

**FRUITLAND TOWNSHIP
White Lake Ambulance Authority**

Shall the White Lake Ambulance Authority be authorized to levy a tax at a rate not to exceed 1.9 mills (resulting in a tax of \$1.90 for each \$1,000 taxable value if levied in its entirety) on all taxable property within the limits of Fruitland Township for a period beginning with the December 1, 2026 and running to the December 1, 2030 tax levy year (inclusive), which would raise in the first year of such levy, if collected in its entirety, an estimate revenue of \$793,319 to be used for operating purposes?

**FRUITPORT CHARTER TOWNSHIP
Public Safety Renewal Millage Proposition**

Shall an expiring increase on one and one-half (1.5) mills, reduced by required rollback to 1.4892 mills, in the limitation on the total taxes which may be assessed against all property in Fruitport Charter Township, Muskegon County, Michigan, for all purposes in any one year, be increased and renewed for five (5) years, 2026 through 2030, inclusive, above the 15 mill tax limitation, in the amount of one dollar and fifty cents (\$1.50) per thousand dollars of taxable valuation (1.5 mills), to provide funds for police and fire public safety services; and shall the Township be authorized to levy up to all of the tax? The estimated revenue the Township will collect if the millage is approved and levied in 2026 is approximately \$1,216,208.00.

Police Department Renewal Millage Proposition

Shall an expiring increase on one (1) mill, reduced by required rollback to 0.9845 mills, in the limitation on the total taxes which may be assessed against all property in Fruitport Charter Township, Muskegon County, Michigan, for all purposes in any one year, be increased and renewed for five (5) years, 2026 through 2030, inclusive, in the amount of one dollar (\$1.00) per thousand dollars of taxable valuation (1.0 mill), to provide funds for police protection purposes; and shall the Township be authorized to levy up to all of the tax? The estimated revenue the Township will collect if the millage is approved and levied in 2026 is approximately \$810,805.00.

**WHITEHALL TOWNSHIP
Extra-Voted Millage for Whitehall Township General Operations**

Shall Whitehall Township impose an increase of up to 2 mills (\$2.00 per \$1,000 of taxable value) in the tax limitation imposed under Article IX, Sec. 6 of the Michigan Constitution, and levy it for 20 years, December 1, 2026 through December 1, 2046 inclusive, for the purpose of Whitehall Township general operations, which 2-mill increase will raise an estimated \$184,000, in the first year the millage is levied.

Extra-Voted Millage to Maintain and/or Improve Public Roads

Shall Whitehall Township impose an increase of up to 1.5 mills (\$1.50 per \$1,000 of taxable value) in the tax limitation imposed under Article IX, Sec. 6 of the Michigan Constitution, and levy it for 10 years, December 1, 2026 through December 1, 2036 inclusive, for the purpose of maintaining, repairing and/or improving public roads within Whitehall Township, which 1.5-mill increase will raise an estimated \$138,000, in the first year the millage is levied.
